

## **CPT® Category II**Coding Tip Sheet

## What are CPT Category II codes?

Current Procedural Terminology (CPT) Category II codes were developed by the American Medical Association (AMA) as a supplemental performance tracking set of procedural codes in addition to the Category I and III coding sets.

- Category I codes are used for tracking and billing for common procedures.
- Category III codes are temporary codes for emerging technology.
- \*\* Category II codes are optional and intended to be used for measuring performance on quality metrics such as Healthcare Effectiveness Data and Information Set (HEDIS®).

Category II codes are alphanumeric and consist of four digits followed by the letter 'F.' Category II codes are **NOT** billing codes; they are used to track services on claims for performance measurement.

Category II codes are not to be used as a substitute for Category I codes.

## What is the purpose of CPT Category II codes?

Category II codes are intended to facilitate the collection of information about the quality of care delivered by coding a number of services or test results that support performance measures. L.A. Care Health Plan highly encourages clinical office staff and billers to use CPT Category II codes. It is anticipated that the use of Category II codes for performance measurement will decrease the need for record abstraction and chart review, thereby, minimizing the administrative burden on physicians and other health care professionals seeking to measure the quality of their patient care. CPT Category II codes can be used to close HEDIS Gaps and can increase your P4P payment.
